# **Special Need for Operating Funds: We Need Your Help!**

Dear Friends and Supporters,

Over the past six decades, we've weathered many challenges, but none quite like the one we face now. As you know, we've been engaged in an exciting Capital Campaign for our new facility, and we're thrilled to report that we've raised almost 90% of the needed funds! Thanks to our donors' incredible generosity, the dream of a new, state-of-the-art facility is becoming a reality. The building pad is nearly complete, despite some setbacks from recent storms, and we invite you to drive by and see the progress for yourself as construction becomes more visible this fall.

However, while we've been focused on this major milestone, our **operating funding** has unfortunately taken a hit. Our Treasurer, Wayne Lewis, who has always kept a close eye on our finances, has expressed concern as we've seen a significant drop in the operational funds we need to keep our day-to-day programs running smoothly. This isn't at all unusual for organizations during a major Capital Campaign, but we need to address this **immediately** to avoid sacrificing the vital programs and services that so many depend on.

**The reality is this:** We have mouths to feed and young people to help between now and the end of this year, and on into 2025. Our new Executive Director, Nicole Jennings, is doing a wonderful job and her entire team has been working tirelessly to save money wherever possible, but we need your immediate support to ensure that no programs are cut, and that we can continue serving those who rely on us.

At the same time as some of our donors have switched their emphasis to the building campaign, we – like you – have been hammered by the inflation and price increases of recent years. It costs more to hire and retain quality personnel, and minimum wage increases are coming. The Center's utility bills – and those we pay on behalf of the clients we help – are way higher than they were not so long ago. And you know from your own trips to the grocery store that the food we buy for our Pathways kids, and the groceries we give to our hungry clients, costs us a lot more than was the case not many years ago.

#### How You Can Help:

• Consider a special gift to our **Operating Fund** to keep our programs strong. One way to do this could be using required distributions from IRAs in a tax-advantaged way as discussed elsewhere in this issue. Continue to support us with your **prayers**, encouragement, and visits to see the progress we're making on the new facility.

• Share this message with others who believe in the work we're doing and who might be able to help us in this critical time.

Together, we can overcome this challenge and move forward with both a brand-new facility and thriving programs. We are developing contingency plans, but we hope not to adversely affect either services to the neighborhood or our wonderful and dedicated staff. This is not a panic situation by any means, but it is prudent fiscal management for us to make a special effort to restore the operating cushion we previously enjoyed.

**Thank you** for all that you do and for your thoughtful consideration of this special request. We are deeply grateful for your partnership and commitment to making a lasting difference in our community.

### **Maximize Your Impact**

Individuals age 70½ or older can make a qualified charitable distribution (QCD) of up to \$100,000 per year directly from their IRAs, including inherited IRAs, to an eligible charitable organization. For most taxpayers over age 70 1/2, making a QCD can have the same effect on their tax liability as a tax deduction. A QCD can even favorably affect the income-related portion of Medicare premiums.

QCDs can count toward satisfying an individual's required minimum distributions (RMDs) for the year if certain rules are met. However, if an individual makes a tax-deductible contribution to their IRA after age 70½, the amount the individual can exclude from their taxable income as a QCD will generally be reduced.

Make sure to work with your tax advisor to ensure that you satisfy all the QCD requirements and that you have correctly reported QCDs on your tax return.

If you're not yet 70 ½, you can still give to charity by donating appreciated stock directly to a qualified charity. If you meet certain requirements, this may allow you to avoid the capital gains tax you'd owe on the stock while also creating a tax deduction for the donation, as long as you itemize your taxes.

As you plan your charitable giving for the remainder of 2024, please consider a Qualified Charitable Distribution to the Presbyterian Community Center. Thank you.


